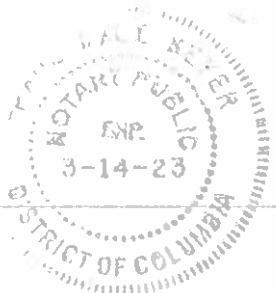

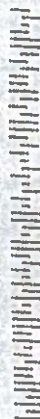

Ma'am:

I have arraigned to have this letter hand delivered to your office, no US mail or internet, and have typed this letter on an old typewriter so there is no trace of it on the internet. If I sent it email or U.S. mail you would never receive it or see it.

I have been directed not to discuss what I am about to tell you, with anyone, specifically being told not to tell Mueller or the Democrats "Anything". What I reveal below makes it clear why people want me to remain quiet.

So you don't feel like reading this letter is wasted time, let me tell you in short form what I actually possess -

Audio; Video; U.S. South COM original orders; JAG directives; Hundreds of banking documents -and-

Hundreds of emails between myself, Julian Assange, Don Trump, Jr., Roger Stone, P. Manafort, J. Kushner, two from Trump, Sr., (one prior to election, one after he is in office), [forwarded to me by Stone], Victor Prigozhin, Mariah Petrakova, Senator Grassley, and his smart ass Aid, Michael Zona.

These idiots actually threatened me and directed me to never discuss with anyone what I am telling you, and they believe I gave them all originals of everything I possessed, and believe I have destroyed all electronic email communications. These people destroyed my life, and for some reason they feel they can threaten me to cause further harm, but in my situation, there is no additional harm they can cause other than my death, and I am not worried about that.

What I have is more relevant than anything used to date against anyone in office or associated with office holders, the damages this is going to cause is larger than life. Taking it to F.B.I. or C.I.A. would cause it to be destroyed and suppressed, so be careful whom you discuss it with at first. I have a plan to use it correctly, safely, and it destroys a large group of Republicans, and three Democrats whom were aware of what I am about to tell you.

My story and life goes way back in D.C., its all over the internet and in books and electronic articles, documentaries, etc... Some people say I am dead, I'm hiding and/or in a prison for some nasty crime.

Obviously I am alive, and I have been quiet for about fifteen years, all the while gathering more information, damaging information, that I can use against people to be named herein this letter to you, as a way to protect myself from the ambush I am going to receive in the event you make any of this public, which I say to you here and now I agree you can do if you so desire.

Prior to looking me up on the internet, I ask you to first finish reading this letter, and then do whatever search you wish.

If you have a friend whom knows what U.S. Military D.E.E.R.S. is, you can have them look me up on D.E.E.R.S., just look for Delmart E.J.M. Vreeland, II, DOB 5/20/1966, SS used 377-80-2556. It will say Lt. 03 pay grade, entry 1985 and active duty at this time. All other information about me in that system was erased to protect me and the various government officials whom used me as they so desired. They even erased my blood type, a major thing required in the field in case of injury.

I want to first talk about what I have regarding Trump SR, JR. Stone. Manafort, Assange, Kushner, and their contacts in Moscow, also my contacts, Victor Prigozhin and Mariah Petrakova.

As a result of travels around the globe I ran into Julian Assange in the Netherlands, we were in the Hague in 1996 at an "Star Wars" missiles systems convention held for government actors. We were doing things we were not supposed to, i.e., illegally spying and taping people, etc...

Julian and I stayed in touch over the many years, even when he went into the embassy at Flat 3B, 3 Hans Crescent, London, England, UK SW1X0LS, we still communicated by email and letters. See USPS.COM tracking LC112-757-245US as the last letter I sent him for Christmas last year (2018).

In January 2016, I received a letter from Julian telling me he had an email account set up for me at RUTV, russian television, via Petrakova, he gave me logging-in instructions, after I confirmed, Julian sent me my first email via the Russian system on 9 Feb 2016.

Before you think it, yes, of course I saved every email in original HTML format with tracking/routing identifications, as soon as Julian told me there was an program that erased it all and covered it so we were protected, I knew he was up to no good and saved it all to save myself.

The 9 Feb 2016 email, identified as "000-0036-1C6F20D.C62D9310", said in relevant parts - He [Julian Assange] is at the Ecuador Embassy, email are safe and can not be seen by U.S. actors. Trump is running, Julian spoke with Prigozhin and "Roger F--king Stone", Don Jr., and Kushner, and made a deal about the Clinton server, hits on Podesta server, what and when to release as much bad shit as he could. He said he was made a deal for extradition to USA and for pardon after he was here, and to fight extradition to make it look good. **The best part**, he was paid bank to bank, I got the account number of the sending Trump account, and the receiving account for Julian, and it is a flat \$10,000.000.00.

(In another email I will disclose, Julian says Manafort tried to steal almost half the ten mill payment)

I was asked what I had on specific Democrats, if I would help, and told what I would get in return.

I was told Julian gave the email address he created for me to Stone.

After I responded I received more email, noteworthy was email 18 March 2016, identified as "_000_007B_01C714D6.E8F55EAO", here Julian says to me -

"Did you see the first batch? :-) Prig said "THE MAN" (Trump) himself said start it so I/We did. I wish I could have seen Clinton's face, or better yet, that flipping Obama's when they hit..." "Podesta is out next target..."

Julian then asks me if I received an email from Senator Grassley's Aid, a "Zona" Julian says he is "Slick".

There is much more in it then I am saying here, all bad for all of them.

After I responded, and received more emails, I received email 20 May 2016 (my birthday) identified as "_000_020_06C369D5.E6F33EAO", directly from that bitch Petrakova. It says happy birthday to me. Tells me all about her love of Julian her "sexy boy", she tells about how she set up my account so I don't have to worry about being caught, and then tells me Julian told her and Vic Prigozhin what I was doing in Moscow in 2000, and what I left with, and how I better send it back, etc.... and she comments on having a photo of my son in Toronto. She talks about Jack Punches, Captain Jack, the real one. She knew all about my action in Moscow and that Jack sent me from the Pentagon. It was mind blowing.

14 September 2016, email identified as "_000_054_01C719D6.E6F44E10", arrived from Julian telling me not to use his names in emails as it makes it harder to remove traces of the communications, etc... bunch of crap. He says he also obtained all of Trump and his team's emails, he says Cohen, Stone, etc... Talks about blackmail to get what he wants, and about how he will deal with Clinton if she wins, which he said, she would not.

9 January 2017, email identified as "_000_0022_1C2F38D.C66D9810", said, from Julian, "He's in and we own his ass and the White House!" (exact words) he says Trump Jr, Stone, Grassley are worried about me telling on them and making a deal with the feds or Dems. This is the email where Julian says Manafort tried to scam half the payment from him in a bank wire scam. Julian tells me he has stuff at 56 saved to protect himself, 56 is an address of a bank outside the U.S., to which I have the box number and account number. He, Julian, then steps on my wrong toe and tells me this - he was sorry for telling Prigozhin what I did in Moscow in 2000, and that Trump had made a deal to return what we had taken, but some materials were required to make it work, so I should give up access codes etc..., to get in "their good graces again". So I go to Moscow, my partner is murdered in the embassy, my life is destroyed and he wants me to return what we took to get in their good graces. Real piece of work, or something, here I tell you.

Once Julian told me Kushner and "Roger" were making a deal to get the stuff from me to Moscow, I chose to gather up my materials and destroy them all.

That email also talks about stealing what is called an "NSA TOOLKIT" clone. The email is enough to get Julian, and several other, a cell next to HANSEN at supermax.

4th of July, 2017, email identified as " 000 055 01C71228.211287C0", from Julian, it starts with "Merry 4t of July", what kind of person uses the term "Merry" as to the 4th of July, I am trying not to swear in this letter; so I will just say, Julian sound like a British Dumb ---.

The email says that the money was paid by Donald Junior for his daddy, it went to UBS, discusses his promised pardon, and names a bank branch in Hong Kong by the Ecuador Embassy, Malaysian Embassy at Gloucester, bldgs 50 and 56.

This one is really gonna piss you off -

1 August 2018, email identified as " 000 0073 01C71486.301627C0", and it is from michael.zona@grassley.senate.gov. He says, Grassley's aid, in a kiss ass fashion, he received my email from Roger Stone (the one Julian gave Stone), I am being asked by Zona if I had anything on Kavanaugh that I failed to turn over previously, i.e., a few telephone call conversations I illegally, according to them, recorded of me and kavanaugh talking, and other stuff. They did not want any surprises in any future/possible U.S. S. Ct. appointments, etc... he wanted tapes and documents, etc... and he specifically says Kavanaugh.

I responded and told his ass off, I accused him of questioning my honesty, and said of course I handed everything over. [I lied] I kept copies of **EVERYTHING!**

I responded to the emails from Zona each time they came, he then sent 6 August 2018, email identified as "_000_086_01C6F130.245328F0", from Zona, says in part - I am going to receive what was promised me by December 2018, he tells me he communicated with Assange, and that under no circumstances am I to talk with Mueller, if I am found and questioned, I am to lie, Zona tells me the following "You of all people should know, if you start talking, you could end up dead..."

Several other emails I received from Stone, Assange, Zona, and both Prigozhin and Petrakova threatened that I would die if I spoke about anything.

Other email discuss conversations between Stone and Kushner where they talk about Trump withdrawing troops from Syria, this email is dated 13 December 2018, and the email says the troop withdraw is some deal between Trump, Sr., and Putin and says someone named "Zakharova" was the go between setting it up with Stone and "Prig".

These are just some of the emails I have, I also have actual voice telephone recordings as well.

You can see from these few I pointed to, there is proof of what Trump and his clan were doing.

Now let me tell you the back story, where I am and how I got here.

A long time ago I joined the USN, 1984 actually, reserve 1984, active 1985, November. Prior to joining I was trained with weapons starting at 7 years old, I used to shoot long distance in a German shooting club, and won a few "shootzen fest" as a kid. (phonetic)

I started working for ATF at the age of 13, my step father was connected and got me a job wherein I would set up middle eastern beer and wine store owners in America, I would enter the businesses and purchase beer and wine and drugs from the foreigners, and I was just 13. I would hand it over to ATF when I left, they would get arrested, I would appear and testify as the cute little white kid whom was abused by the middle eastern men, they got charged, convicted, sent to prison, and deported, local authorities and ATF split the proceeds for each shop.

As a child my step father thought that teaching me to kill was great, but he hid what he was doing to me from my mother. I was caught between being good and wanting to be a kid and then teen.

After I enlisted I got sent to D.C. in 1985 right away, trained at a place I will not talk about in a letter, and was taught to steal, kill, disguise and spy. I was really good at all of it, especially when I was brain washed into thinking it was all ok if the U.S. Government told me to do it.

The things I was doing caused me to drink and use drugs, the drugs were supplied by the DOD. I was able to get cocaine to keep me going and then klonazepam, or sedative, for free and as much as I wanted, and an unlimited budget to run wild all over the globe. If I got in trouble, military was there to get me out of it every time.

When the U.S. Government trains you to kill, they kiss your ass and use you until you are used up or dead. Criminal records, some are real and some are created to assist the person you need to become to accomplish the objective.

IN 2000 I got sent to Moscow to do a job. I was to break in, kill, steal, get home with the package. I did it all. As they were Russian (Enemy) targets, I never blinked and eye. My contact was a Canadian named Marc Bastien, he was an "alleged" senior systems analyst at the embassy, but really a C.S.I.S., "Canadian Security Intelligence Service" agent. The google I sent you to shows a fire at the Russian defense ministry in December 2000, the story by the Russian gov was B.S., there were bodies, and both Petrakova and Prigozhin mentioned it in the emails I mentioned above. (I have it all).

After I get what I went to get, Marc and I ended up with a diplomatic pouch that we, of course, cut open. Inside was paper documentation about the up coming 911 terrorist attacks in New York. There was an actual letter from Kудay (Odai) Hussein, or (Uday) [different spellings my phonetics], and it detailed who, what, when, where, and why - and whom in the U.S. Government was involved in the 911 attack. (It also mentioned me and Marc and our deaths)

Marc and I agreed to get out of Moscow with the documents and to meet in Toronto, Ontario, Canada, and then deliver what we had.

I get to Toronto, I get a call on a phone that only Marc and Jack Punches had the number for, I am told to immediately get what Marc and I had obtained and to go to a place in Toronto to pass the materials and be debriefed. I was in a low rent room in the Falls, it was snowing real bad, so I hired an limo driver to drive me the 3 hours to Toronto late that night, never telling anyone where I was.

I get to Toronto, and my suspicions were correct, the car was immediately surrounded by men with automatic weapons, and I was taken away to a place where I was waterboarded for what seemed like forever. See, the agents were pissed that I (i) did not admit to being me, and (ii) did not have the package on me, I only had a bag with torn up phone book pages in it and nothing more. I had no ID, no phone, nothing, just alot of cash and a limo.

I am then taken to an immigration detention center and held. As time was ticking and I could not get to Bastian or Punches, I told the jail super that I was an agent and needed to talk to C.S.I.S., and informed there was going to be an "act of war on US and possible Canadian soil".

I was segregated. Taken to a place called the dungeon in Ontario, and in August 2001 I was interrogated by C.S.I.S. with my lawyers present. I said, my contact in Moscow, Canadian C.S.I.S. Bastien, was found dead in the Canadian embassy in Moscow, he was murdered with Klopazine. I told about the plans of an terrorist attack on New York.

I was placed back in segregation and told to shut up about it. The U.S. officers told me that I was forbidden from discussing my trip to Moscow or my conversations, (RECORDED) with B. Kavanaugh, wherein I informed the W.H. via Brett about what I had obtained on an emergency line used for these situations that Punches authorized me to use.

Because this will no doubt go public, I want to make it clear, I broke orders and called the White House on the emergency line as I was told by PUNCHES, without talking to any other senior agent first, **and recorded the call**, to protect my ass as people were trying to kill me and Marc had not responded to any message from me as he was dead in his apartment at the Canadian Embassy, Moscow.

Further clarifications, - I always recorded every call where I was told to do anything which may not be so legal wherever I was going to do it, I did this to protect my ass, just as almost every field agent does. Especially when they are sent to kill.

So, I told Clark, I told C.S.I.S., I told Robert Mueller, I told the U.S. Embassy, Ottawa, Ontario, Canada, F.B.I. liaison, and Brett Kavanaugh, all on recorded and/or videotaped lines/conversations that the 911 attack was planned, and what bastian and I obtained. I gave fair warning, I did everything I could do. Not one person did anything about it.

As to Kavanaugh, when we spoke, he was in the W.H., half drunk, and told me to shut up, have a drink, etc... he is such an ass. (That was why I punched him in the mouth at the ESPN Sport Zone down the street from the Harrington.) There was more to it than that, but it was a factor, plus he let Jack die.

So, after the 911 attack I am granted temporary refugee status in Canada, people all over the earth are writing stuff about me, Tucker from FOX was stalking me in a bad way, he was all in for the Republicans, he could have seen a video of me telling Bush about the attacks before they happened and his ass would have lied about it to save the Republicans, and his job. (I am not sure who he was working for at the time, but the computer prints from his emails to me are real bad.)

Anyway, I am living in Canada and I am all fine. I get meetings at my home from USG agents asking me to come home and stop talking. I had the house set up with audio video of all meetings (still have it all)

In 2003 I am asked to do a job in Colorado that will make it all good and even and all will be forgotten. I agreed, like a dumb ass.

I am sent to Colorado in August 2004. I get a vacation rental all paid for and an unlimited budget. I am there less than 30 days and the house is raided by local police. I am arrested, charged with sex crimes, and taken to jail.

I am held without bail, and then after two years I am forced to jury trial in a closed courtroom, and denied a lawyer, I had to try case alone.

The jury finds me not guilty of the most serious charge, so, to hang my ass the court enters conviction anyway, and sentences me to 24 years to life for a crime the jury found me not guilty of.

I sat for 15 years without ever gaining access to the jury verdict forms, 6 months ago a court ordered them produced, and I was correct, it says, "We, the Jury, do not so find."

A group of democrat lawyers are trying to get me out as I write this. I even have help from non democrats there in D.C. whom are assisting. I have told you very little here. I have so much to tell but have been pressed at every stage when I tried. I have been locked in a cage for years, the emails from Zona, Senator Grassley's Aid, he is promissing me to get me out if I agree to help and not talk about Brett and other things. I felt it was valid as Grassley was the man whom caused my arrest in Iowa, transfer to Colorado, and convictions. Of course they screwed me over, again.

I have all the videos, audios, documents, emails, bank records, etc... and the only way to make it public is to get someone to make a game plan to let it all out and protect me at the same time. F.B.I., Wray, Barr, CIA., that is not gonna work, they would make sure I never spoke, especially the new CIA director, Ms. H, she would love to see me dead cause I got shit on her that would destroy her from way back.

Anyway, I am telling you now, I have everything safe and sound that I have told you I have. I have a plan that is safe for me and other whom would come out of the dark to reveal what they have. My plan includes you, the NY Governor, and the Colorado Governor.

I have the ability to call anyone, any time, not collect. I just need a name (not yours) and a telephone number with area code.

I think New Yorkers have a right to know what really happened on 911, why, and who knew, and whom covered up what. They should be allowed to hear/see audio/video, they should know the truth.

Delmart Mike Vreeland seems to be a man who apparently had foreknowledge of 9/11. The heart of the matter is that Vreeland, who says he is a US Naval Lieutenant assigned to the Office of Naval Intelligence (ONI), finds that his claims are "increasingly being corroborated in court."

FTW INTERVIEW: DELMART "MIKE" VREELAND

What the CIA Doesn't Want You to Know

April 4, 2002, 2:00 PM PST (FTW) -- If all of its dark alleys were explored, the case of Delmart Edward Joseph "Mike" Vreeland is one which is worthy of a book that would rival "War and Peace." It is a case that has sparked zealous attacks on FTW and me personally, and one which has seriously disturbed many officials in Washington. These attacks are an indication of the threat Vreeland poses to the credibility of the U.S. government. Only one question of any relevance exists. How was this man able to write details that described the events of Sept. 11 while locked in a jail cell, more than a month before the attacks occurred?

It matters little to a housewife in Kansas if Mike Vreeland has a very confusing criminal arrest record -- some of it very contradictory and apparently fabricated -- for a variety of petty criminal offenses including fraud. But it may be a matter of the gravest importance for the same housewife if this man knew accurate information about the attacks, tried to warn both the U.S. and Canadian governments about them, and was ignored. If a crazy man runs up to you on the street and says that a house is on fire with children trapped inside, and you smell smoke, who is the crazy one if you decide not to investigate?

The U.S. Navy says that Vreeland, arrested in Canada on Dec. 6, 2000 and currently fighting a U.S. extradition warrant, was discharged for unsatisfactory performance after only four months of service in 1986. But a growing pile of evidence, much of it filed in court records and undisputed by Canadian or U.S. authorities, establishes clearly that Vreeland was exactly what he says he was -- a spy.

In three previous stories, FTW has described how his military records, acknowledged to be in excess of 1,200 pages, have been tampered with. We have described how, in open court on a speakerphone, his lawyers obtained direct confirmation from the Pentagon that he was a Navy officer. We have also reported that, as of March 14, all Canadian charges against Vreeland were dismissed. He was released on bail and also granted temporary refugee status by the Canadian government until his battle to beat the U.S. extradition request is settled.

Something that Canadian authorities have never disputed is that Vreeland wrote his ominous and hastily scribbled warning a full month before the attacks, and that the warning was sealed away by his keepers, beyond his reach, until Sept. 14, three days after the attacks.

If he loses his extradition fight, both Vreeland and his attorneys believe that his assassination will occur within days of his return to U.S. soil.

Mike Vreeland is not a saint. Covert operatives are not made from such material, and governments do not recruit or screen candidates for saintly qualities. By his own admission in Canadian court documents and in several conversations with FTW, Vreeland says he has done bad things. He has been on probation for petty offenses, and he has behaved the way covert operatives behave in the real world – not in Hollywood.

I have been studying, interacting with, and talking to covert operatives for more than 25 years. It is for that reason that I avoid some of the questions being raised by dilettantes and neophyte journalists who take all of the threads of Vreeland's stories and run with them into a wilderness from which no professional journalist could credibly emerge. Yes, I have listened to him talk about so-called "red mercury," baseball-sized atom bombs, and Star Wars weapons systems. Yes, I have heard him talk about a great many things, and I believe that what he told me was truthful according to his knowledge of events and the documents he brought back from Moscow in December 2000.

Even by his own statements, Vreeland, now 35, was a relatively low ranking officer and an intelligence field operative. Never in the history of covert operations has any government entrusted field operatives with total strategic knowledge because the knowledge held by those who make the plans is compartmentalized and locked away. Perhaps 80 percent of all intelligence work is disinformation, and governments know that their field operatives risk capture, interrogation and torture. Quite often field operatives are themselves fed disinformation so that if they talk, they will still spread lies that serve a larger strategic purpose. Quite often they carry documents that are deliberately inaccurate and their capture is engineered to give those documents credibility.

To the U.S. government, Vreeland is totally expendable. And those who run with every piece of information he has disclosed will themselves be proven fools in a fool's game.

But one question remains. And it is a question that now stands vindicated by time and events. He knew something chillingly accurate about the 9-11 attacks before they happened. And if he knew something, based upon documents given to him by Russian officials indicating U.S. knowledge, and if the U.S. government went to great lengths to discredit him, rather than bring him in from the cold -- then there is real meat on the plate for journalists, the American government, and all of mankind.

I have asked him 35 questions, and now you can read Mike Vreeland's answers as he speaks for himself. The first 32 questions were jointly submitted to both Vreeland and his attorney, Paul Slansky, for review. The remaining three questions were asked after the most recent hacking of FTW's website, which we believe was perpetrated by the CIA. This made the publication of this story an emergency and also made a statement about the survival of a free press in America:

1. What part of the U.S. government did you work for? Was it the CIA?

I worked for U.S. Naval intelligence. What the CIA directs us to do is their business, so we have no way of knowing whether we're working for them or not.

2. Was your assignment primarily connected to terrorism/oil?
Yes, on both issues, in part.

3. Why were you in Moscow and Russia in the latter part of 2000?

I was sent there by the U.S. government and the ONI [Office of Naval Intelligence]. I got my orders between Sept. 4 and Sept. 7, 2000.

Marc Bastien departed for Russia on Sept. 7, 2000. I had orders to meet him. Bastien was going to work at the Canadian embassy regarding diagrams and blueprints of a weapons defense system. The U.S. government had a direct influence on his mission. The name of the defense system is SSST [Stealth Satellite System Terminator]. There are five different individual and unique defensive and strike capabilities of the system. The only portion that I have publicly spoken on is one frame regarding actual current orbiting satellites, which are not at this time owned by the US government. On advice of counsel I cannot discuss the other components.

This one component is a satellite system. Within the confines of the system there are multiple, deployable space/orbital EMP [Electromagnetic Pulse] missiles that are not aimed at the ground. They are targeted at everyone else's satellites. These would kill worldwide communications. The satellites of some countries that are shielded with titanium are protected from these weapons. The protected countries are Russia and China, but U.S. satellites are vulnerable and Putin has told Bush that the U.S. missile defense system doesn't work, and that Bush knows it.

The reason why I went to Russia was because I needed to meet with Bastien and another individual from the Russian Ministry of Defense named Oleg. The purpose was to get the Canadian diplomat who had made contact with Oleg to get the book of designs out of the ministry's R&D. That was done. We copied the entire book. Then we took certain documents, and we changed serious portions of the defense design so the program wouldn't work. They know this now.

Additionally I was to pick up docs from other agents and bring them back.

4. You told Canadian authorities that Bastien was murdered when?

I never told them he was murdered. I wrote a letter to Bastien around June of 2001 from jail. I sent it to CSIS [Canadian Security and Intelligence Service] in Ottawa, to the director for his eyes only. I had restructured the diagram to put it back in its original state. But I never told anyone exactly how to turn it on and how to build it. CSIS already knew that Bastien was dead. He died six days after I was arrested on Dec. 6. I was discharged on Dec. 9. He was killed on Dec. 12.

CSIS sent RCMP [Royal Canadian Mounted Police] (Sgt. Mabe, Corporal Kispol) to visit me in jail on Aug. 8, 2001, and they advised me that he was dead. They didn't say he was murdered. They told me he was dead. I told them that if Bastien was dead, it was murder, and that they should get a toxicology report. And I would tell you how it was done, and who did it.

5. When did they finally admit that Bastien was murdered?

They admitted that I was correct in mid-January.

6. When did you first learn details of the attacks that were to happen on Sept. 11?

In the first week of December 2000.

7. How did you learn of the details?

One document was written in English by a U.S. agent, who had picked up a copy of a document that had been sent to V. Putin by K. Hussein, Saddam Hussein's son. This is what the translation of the doc indicates. The Iraqis knew in June 2000 that I was coming. I didn't get my orders until August. The letter said that Bastien and Vreeland would be dealt with "in a manner suitable to us." The letter specifically stated on page two, "Our American official guarantees this."

8. Who put the information on the attacks into the pouch, and what would have been their motive for doing so?

I am not allowed to answer that. It would jeopardize the lives of active agents, and it would violate the National Security Act of 1947.

9. After having learned of the details of the impending attacks on the WTC and the Pentagon, how long did you wait before trying to notify Canadian and U.S. authorities of the information?

On Dec. 6, 2000 I told Canadian authorities to their face that I needed to contact the Canadian military immediately. I wrote it down. She [the Canadian official] was playing games, so I wrote down that I was a Russian spy and a weapons systems expert, and that I wanted to talk to them TODAY. I said I was a Russian because figured it would get their attention. The name they had on me was Mikhail Cristianov (Michael Christian), because I had ID that used this name.

10. What was their reaction?

The Canadians turned blue, walked away, and I never saw them again.

11. How did it make you feel?

I was pissed off. It's on video [referring to a standard jail surveillance/security video].

12. Did the U.S. and Canadian response lead you to reach any conclusions? If so, what were they?

I thought I was dealing with idiots who had no clue about what was about to happen. It's been put to me that there were certain officials who wanted the attacks to happen. No one ever had any intention of building the system I was after because it would have made the defense budget obsolete. One thing that happened after 9-11 was that the Pentagon budgets soared.

13. Your written warning contains the statement, "Let one happen, stop the rest." Who was going to let one happen? Who was going to stop the rest?

I can't comment on the advice of counsel.

14. Does that statement imply that the U.S. or some other intelligence agency had achieved complete penetration of the terrorist cells?

That goes without question. Sometimes certain governments design, create networks like Al Qaeda, which was really the government in Afghanistan. Those entities create specific problems at the creating government's direction.

15. Do you know who had achieved this penetration?

I cannot comment on that.

16. Is it possible that the terrorist cells were being "run" without knowing by whom?

Absolutely.

17. The most common excuse people use to discredit you is that you have prior arrests on fraud charges, and there are several press stories linking you to alleged criminal activity. How do you explain this?

The American Express charges are b.s., and Amex has stated on tape that the specific charges in question were approved. They admit that there was no fraud on this card. That card had been issued to Lt. Delmart Michael Vreeland. The Amex people admitted that the card was a U.S. Navy card.

People have accused me of identity theft. If anybody checked with the police departments in the U.S., they would find that there is not one police report form any individual in the U.S. who has alleged that I have stolen any identities. There is not a single identified victim anywhere. Three judges in Canada have denied my requests to have discovery and disclosure on these alleged charges.

The press stories that have circulated about my past are lies. Portions of the stories alleging fraud and ID theft are lies. I have threatened to sue these papers, and the stories have been pulled.

I'm working with ONI. Certain government officials -- politicians, brass, and high ranking military -- have 11th Amendment privileges and can't be sued. Another government agency has to go investigate activities connected to weapons smuggling, organized crime and drug trafficking. They use their power to break laws, and we're not allowed to investigate them. Thus certain parts of the U.S. government designed an entity called UID (Unofficial Intelligence Investigation Division). It was designed by Adm. Jeremy Michael Boorda, who allegedly committed suicide. Boorda put this together prior to becoming CNO [Chief of Naval Operations]. He was not a bad guy.

Intelligence officers are sometimes put into positions where they are given assignments to infiltrate specific organizations that are powerful enough to check out a newcomer's background. Page 335 of the Charter Application in Canadian Court shows a copy of orders from Southern Command. These orders are dated April 18, 2000, concerning an anti-drug operation we were mounting. At approximately the same time the media released widespread stories that I was a wanted criminal. This was a means of providing cover and credibility for me with the people I was infiltrating.

18. How many times have you been arrested on criminal charges?

Maybe three. Some of this I did, like a DUI charge in New York. I had been at the UN, and I had definitely been drinking.

19. How many times have you been convicted?

I have never been legally convicted of any criminal, felony activity anywhere. The drunk driving charge is still pending, and I have admitted in open court that I did it.

20. The Michigan warrant for credit card fraud is based upon the use of your own credit card. How do you explain this?

It is a setup.

21. Were your credit cards authorized or facilitated by the U.S. Navy or any part of the U.S. government?

Yes.

22. Could the U.S. government or any of its intelligence agencies have "inserted" the charges through state and local agencies?

Yes.

23. You were in custody in New York on the date the alleged Michigan offense took place. What was the charge, and what was the disposition of that case?

That was the DUI charge.

24. Was working with organized crime families a part of your duties with the Navy?

Yes.

25. Were any of the organized crime families in Michigan?

Yes.

26. For what reason were you working with organized crime?

I was under orders to do so 90 percent of the time. Organized crime supplies the weapons and drugs that go to the people we investigate.

27. Are you afraid that you will be killed if you are extradited to the U.S.? Why?

Yes. Because I have spoken out.

28. Can you explain why the Canadian courts will not allow your attorneys to introduce evidence that verifies your position with the U.S. Navy?

Yes. The Canadians are totally subservient to U.S. intelligence interests. They're afraid of Uncle Sam. It would also prove that CSIS covered up Marc Bastien's death, and that there was a cover-up involving a member of a major drug organization that had planned assassinations against prominent Canadians. In fact, one individual was found dead in a vat of acid. He was a hit man.

29. What do you want?

I want my uniform back, my back pay at \$4,210.90 a month and my honor. I want President Bush to give me a full and complete pardon and the amnesty of the U.S. government. I am owed that. I want Bush personally to know everything that I know, and what kind of threats there are against the U.S.

It's never going to happen, so I am now seeking permanent refugee status in Canada and the protection of the United Nations.

30. What do you think will happen next in your case?

I don't know. My attorney is in court seeking a postponement of the extradition case because the Canadian government will not allow me to subpoena very important U.S. witnesses from the Pentagon and other places.

31. Is the war on terrorism about something other than what the people of the world are being told?

What war on terrorism?

32. What do you think will happen next in the war on terror?

Eventually, someone's going to have to tell the truth. Once those people are dealt with according to law, there will be no more false terror spread across the globe.

33. You have recently had dealings with an American journalist named Rick Wiles. What is your opinion of Wiles and what was your experience?

My opinion of Wiles is that he is a psychopath, who will print anything that will make him money. My experience with him was that I had private conversations with him that he recorded, not telling me he was going to post them on the Internet and sell them to the world. Then once I contacted him and told him that he was not to do that, he said he would take them down right now. Instead of taking them down he placed a bigger ad. He made a bigger ad!

In my opinion he is neither honorable nor professional. He has placed my story right next to a story about someone who talked to aliens 25 years ago. Yeah, that's right where I want my story to be, right next to some bozo who talks to aliens. The idiot!

So now he's selling this phony exclusive interview with me for \$20 and he's making all the money. He never had my permission to do that.

34. You have recently had dealings with an American journalist named J.R. Nyquist. What is your opinion of Nyquist and what was your experience?

Don't even get me started. My opinion: I think he might be working for the government. I did not know that he was writing a story about me. He asked me some questions. I answered some questions. I recorded it, and then he went off on a wild tangent about psychological crap, and I didn't even read the whole story I was so mad.

He went off about the Russians, and it's all b.s. He sent me this fax about you saying that Ruppert was not my friend. He was saying that the Russians had me boxed in. The truth is, the American government is boxing me in. He's full of shit.

35. Are all of these statements on-the-record?

Yes!
